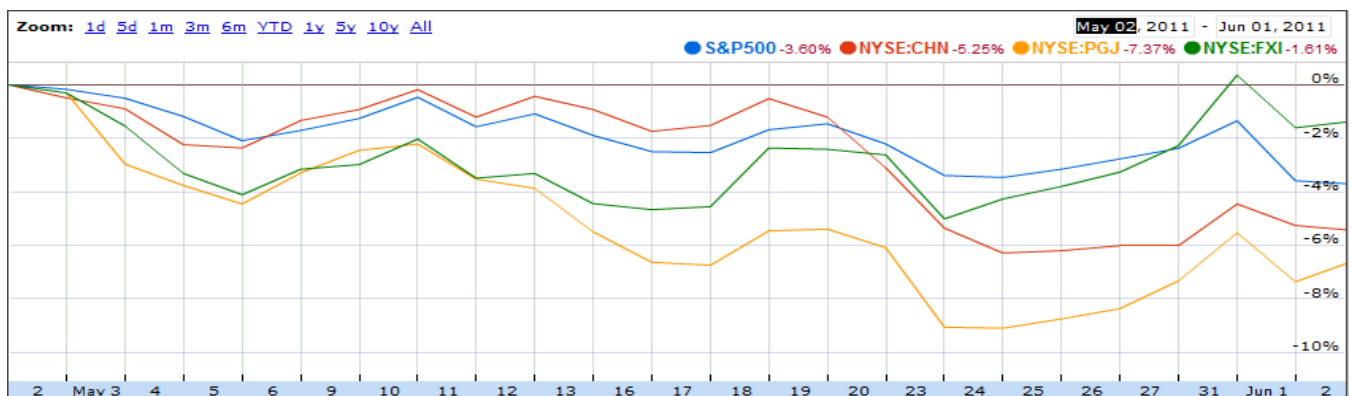

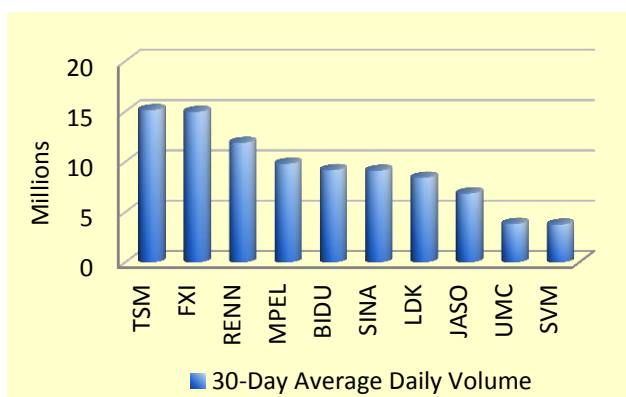
About ORS

As of June 7, 2011, Media Exchange Group, Inc. was acquired by IntelliCell BioSciences, Inc. in a reverse merger transaction. The company intends to acquire or merge with an operating business.
