### About CIIC

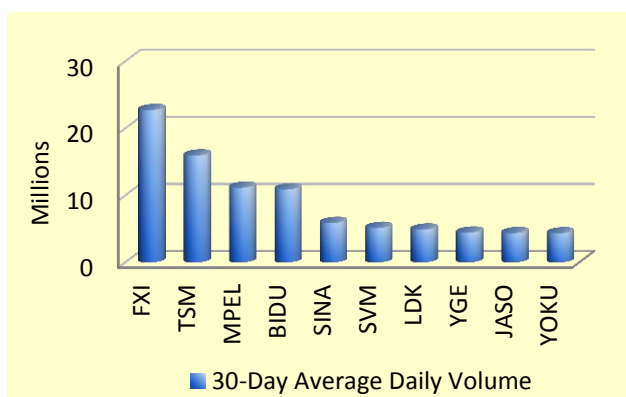
